Dear Sir,

Proposal for acquisition of land under Act II of 1948 in the above stretch was initiated by the Superintending Engineer, State Highway Planning Circle of P.W.(Roads) Department in his letter No. 1811 dated 24.10.1990. LA plan in tracing cloth and blue print, schedule of land and vandyked map were submitted alongwith the proposal. The proposal was assigned Case No. 42 of 1990-91 by your office. It is observed that acquisition has not been completed in the stretch and it is also learnt that acquisition under Act II, as allowed by Secretary L & LR Department as a special case, ~~xxx~~ would not be possible.

Under the circumstances I would request you to complete pending formalities of acquisition under Act I of 1894 as early as possible. Since there has been considerable delay, I would also request you to please invoke Section 17 of LA Act 1894 and waive section 5A of the Act considering urgency of the case. Fund for payment of compensation to land losers has already been placed with the collector.
