



NOTIFICATION

BIRBHUM.—No. 428LA(II)/4B-27/80.—15th January 1983.—Whereas it appears to the Governor that land is likely to be needed for a public purpose, namely, for efficient running of the Tourist Lodge and laying out a well planned carpark within the campus of the lodge in the village of Bakrewsar, jurisdiction list No. 42, police-station Dubrajpur, district Birbhum, it is hereby notified that a piece of land comprising cadastral survey plots as described below and measuring more or less, 0·39 of an acres/0·1578 hectare is likely to be needed for the aforesaid public purpose at the public expense within the aforesaid village of Bakreswar;

This notification is made under the provisions of section 4 of the Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authoise the officers for the time being engaged in the undertaking with their servants and workmen, to enter upon and survey the land and do all other acts requirered or permitted by that section.

exercise of the powers conferred by sub-section (4) of section 17 of the Land Acquisition Act I of 1894, the Governor is pleased to direct that the provisions of section 5A of the Act shall not apply to the arable lands described in the Schedule below to which in the opinion of the Governor, the provisions of the sub-section (1) of section 17 of the said Act are applicable.


