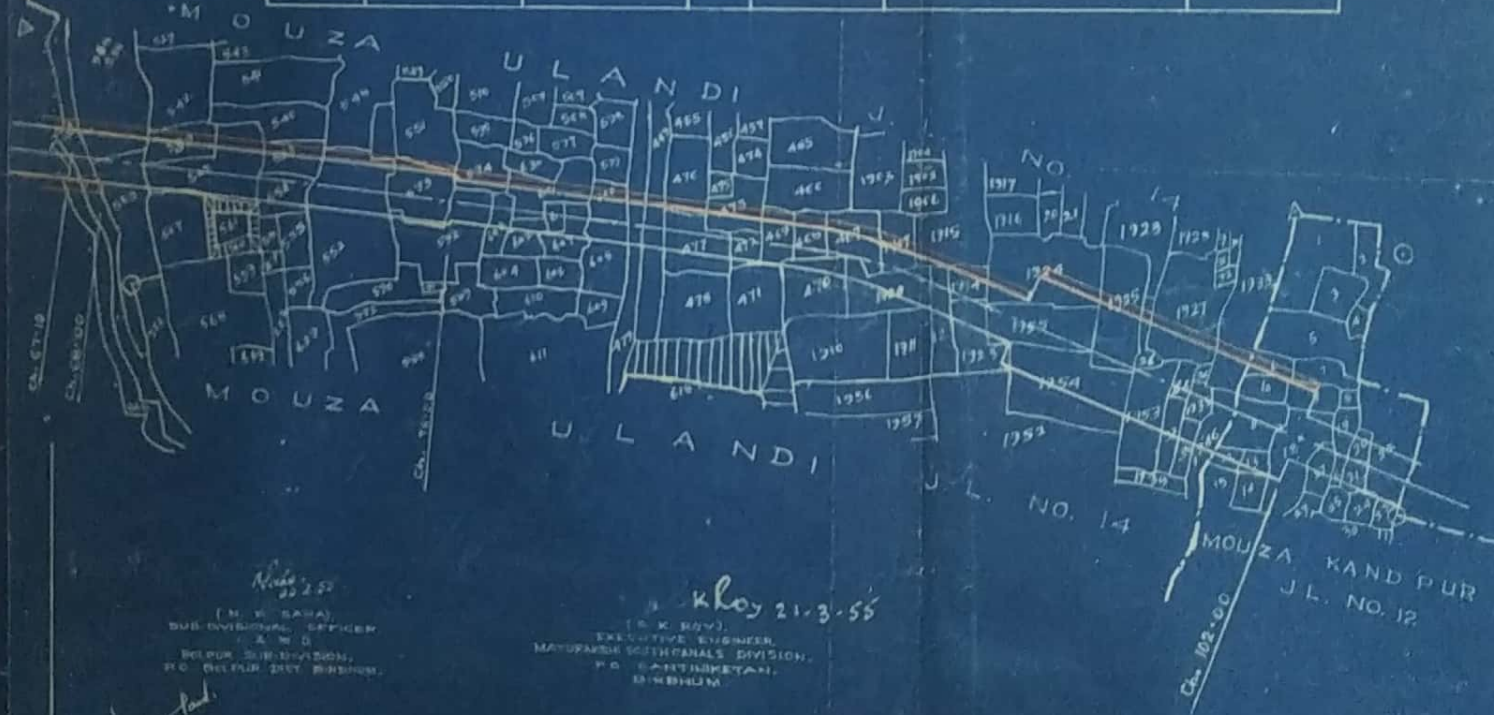

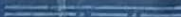

NO. 13 & HNASRA SHEET NO.1, J.L. NO. 28, P.S. ILAMBAZR, DISTRICT - BIRBHUM.

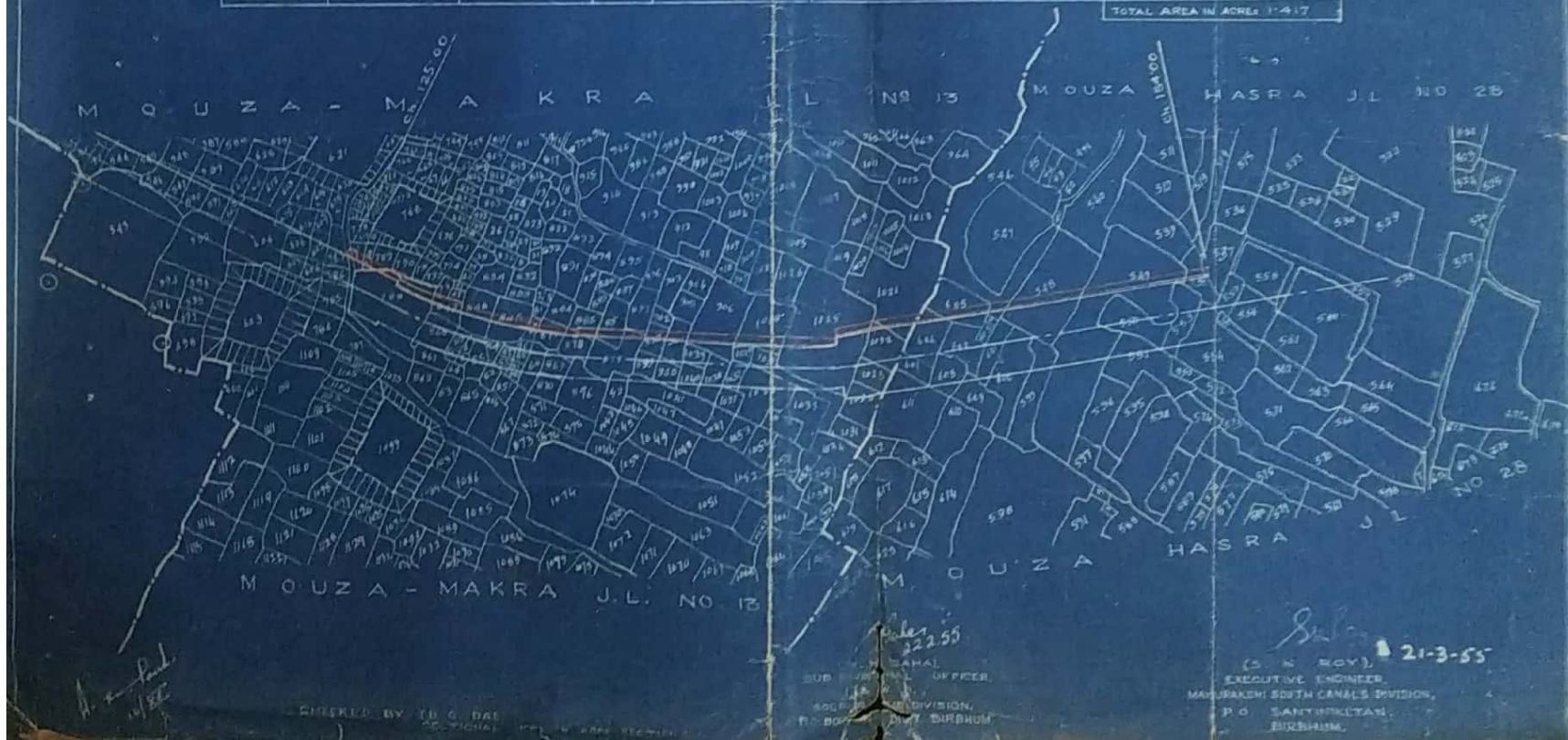

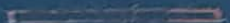
