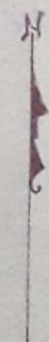
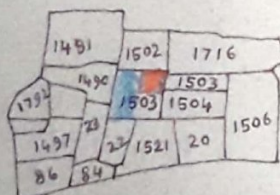
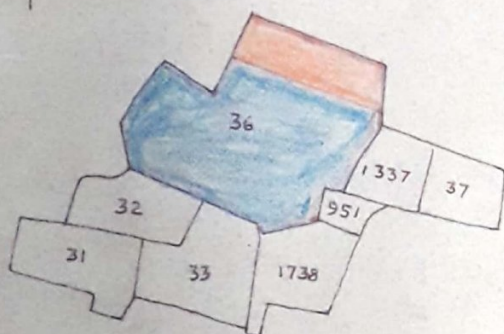


PLAN OF LAND TO BE ACQUIRED PERMANENTLY FOR REGULARISATION

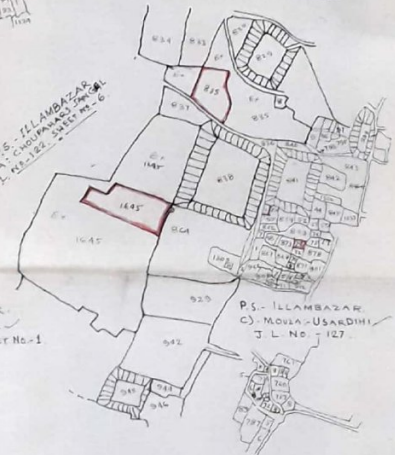

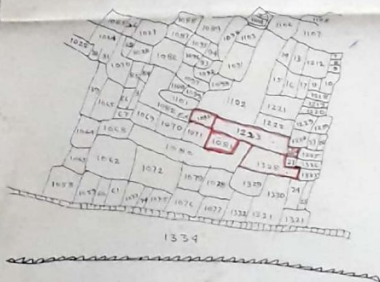
