

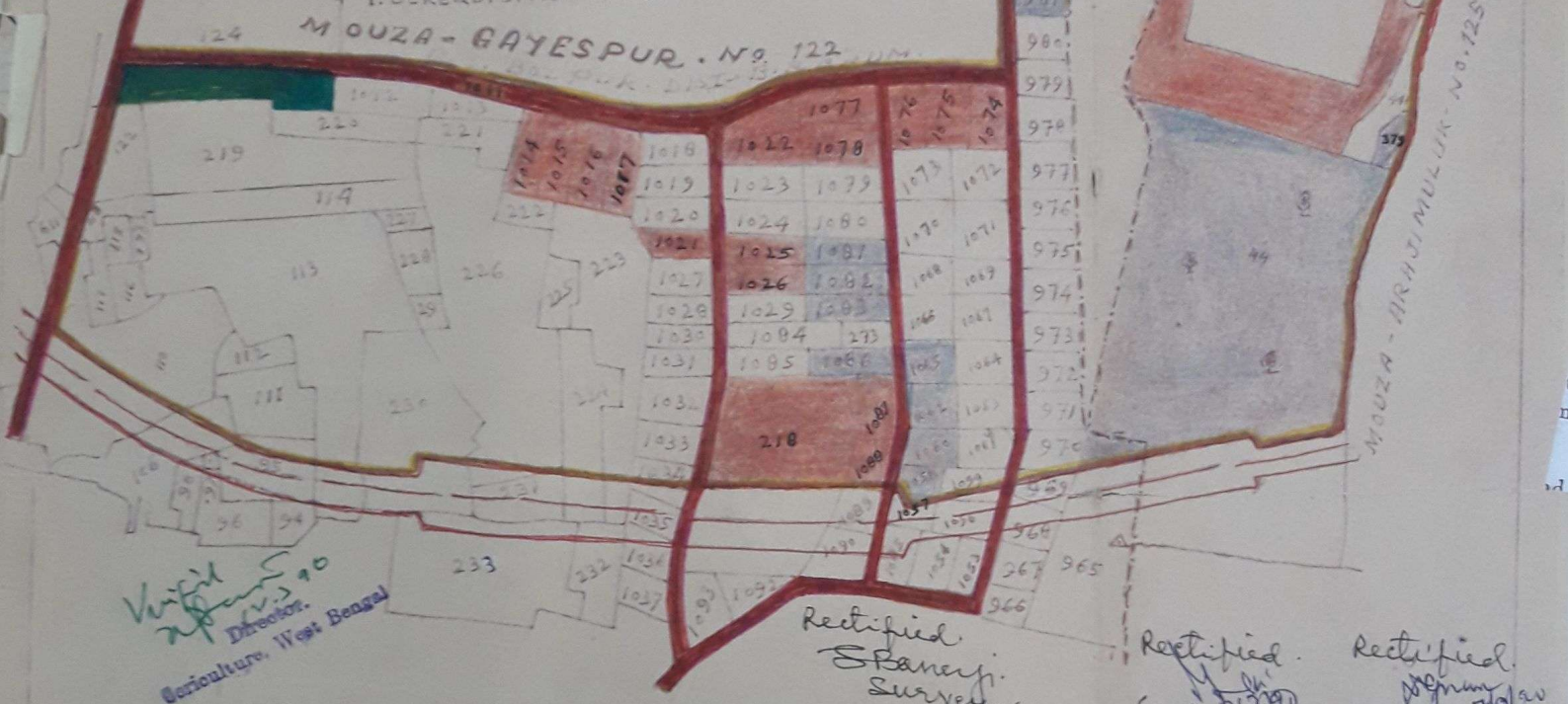
PLAN OF LAND TO BE ACQUIRED FOR REQUISITION AND ACQUISITION
