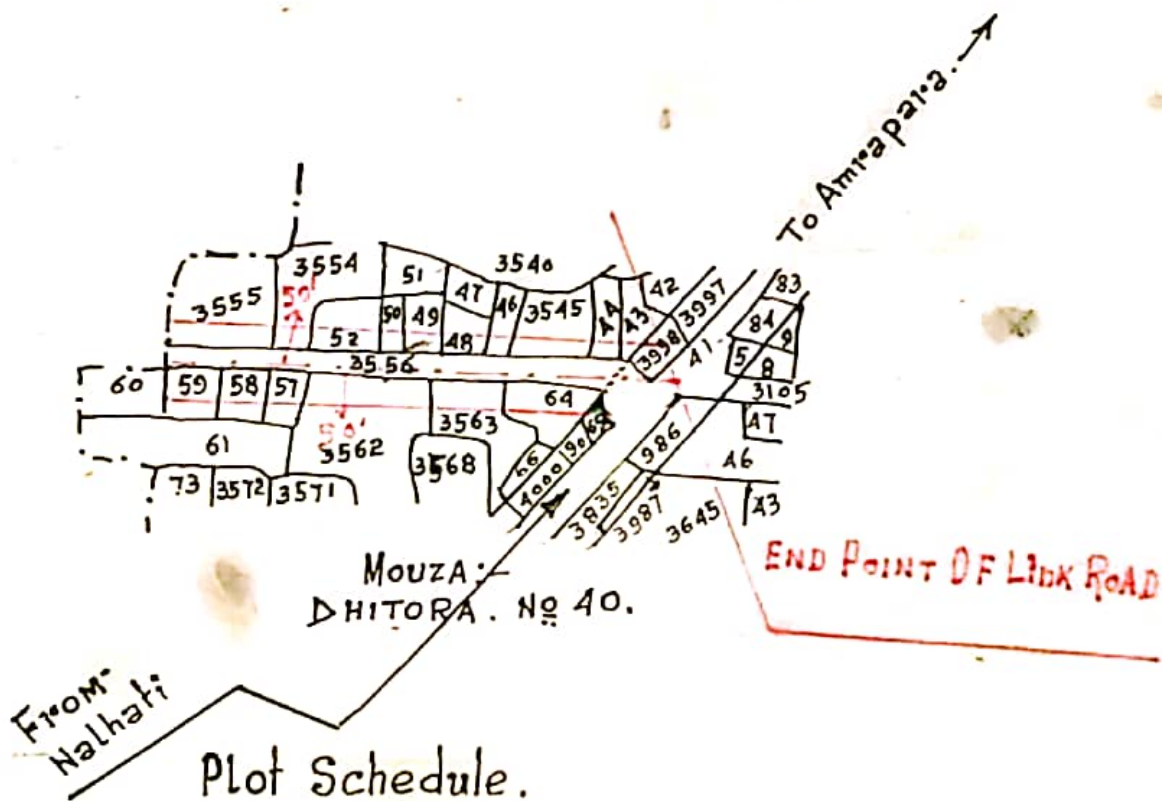

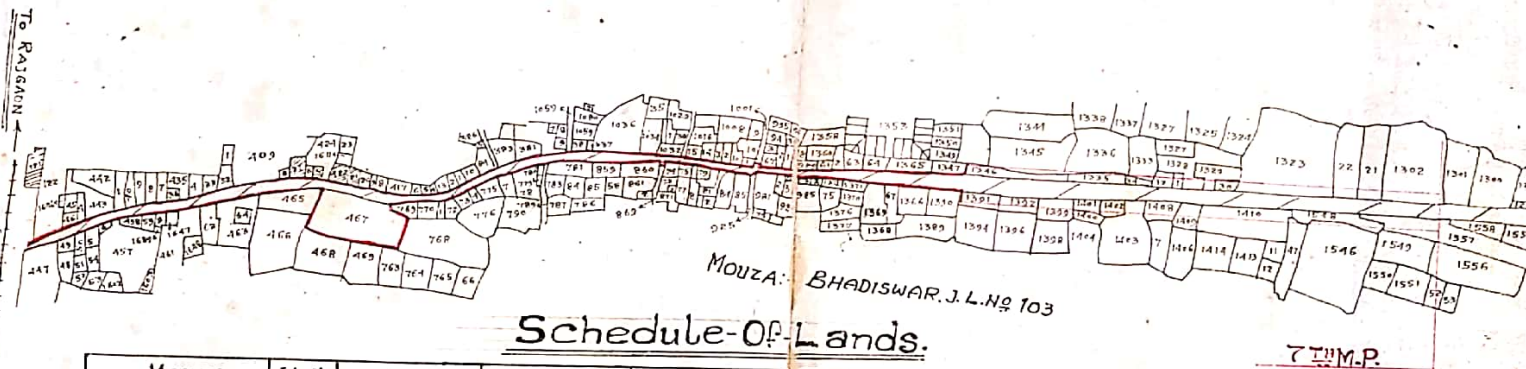

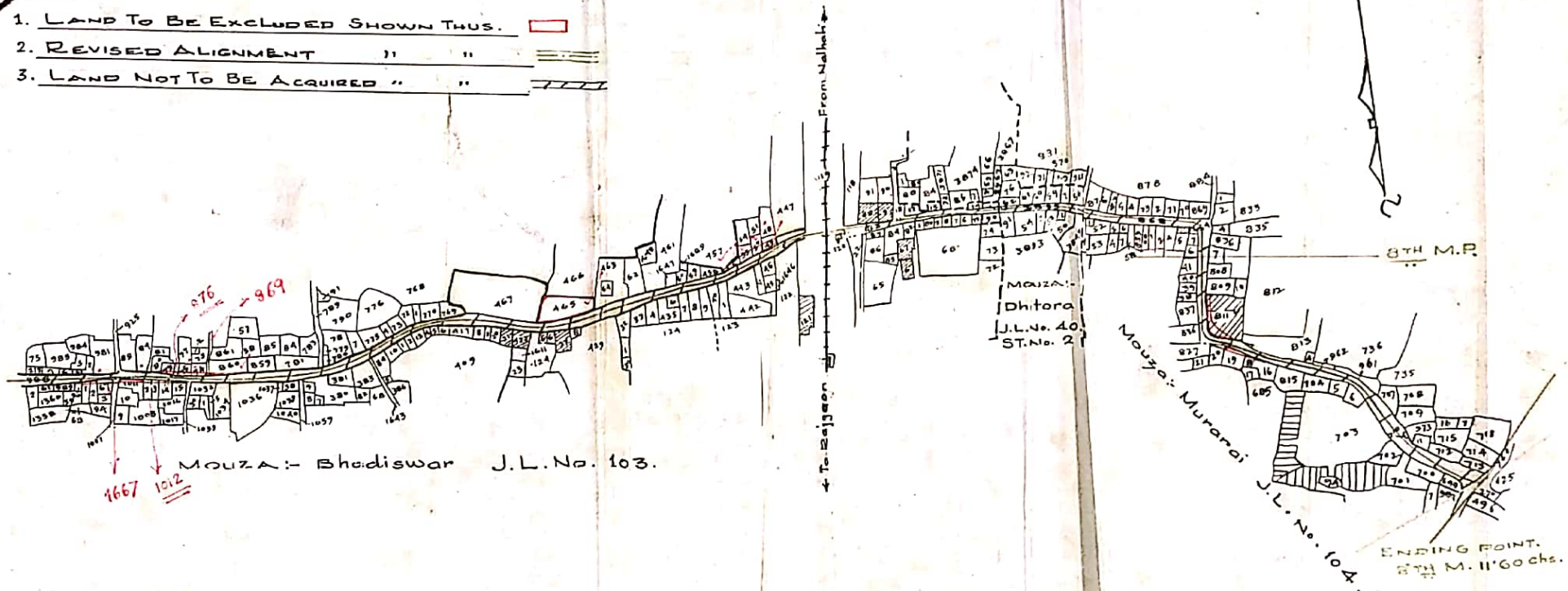
**REVISED LAND ACQUISITION PLAN OF
