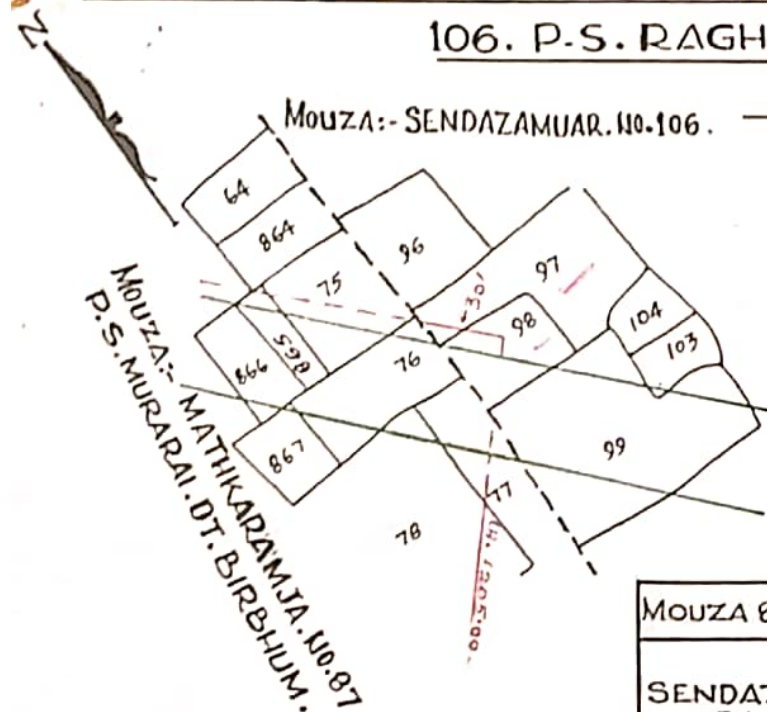


PLAN OF LAND ACQUIRED PERMANENTLY FOR INSPECTION ROAD OF B.N.M.C. OF

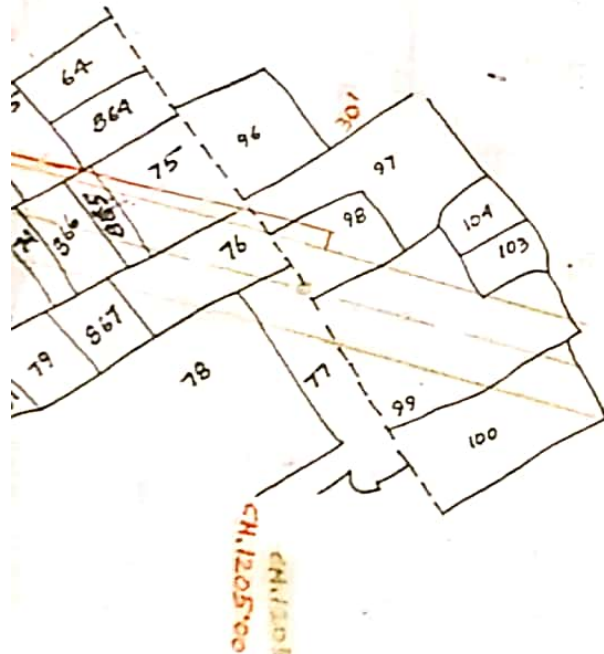
