

BIRBHUM—No. 129911A (P.W./CH)—1st August 1967.—Whereas 2,785 acres 1-124 hectares, more or less of land situate in or near the villages of Khargram and another described below have been requisitioned under sub-section (1) of section 3 of West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) for the public purpose of providing facilities for irrigation and drainage, namely, for minor and water course from chainage 213-00 of Mayurakshi Dwarka Branch 17 (Right Bank) canal in connection with M. R. P.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquire such land being required for the public purpose as aforesaid.

This notice is given under the provision of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
