

BIRBHUM.—No. 2277L.A. (P.W.)/C II.—26th February 1968.—Whereas 1·176 hectares (2·915 acres), more or less, of land situate in or near the villages of Malgram and others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for excavation of new Dy. No. 19A(R) Ex. KSMC in connection with Mayurakshi Project ;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provision of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
