BIRBHUM— No. 7 L. A. (II)/Spl./P W (Roads), dt. 18th October, 1993— Whereas 4.25 acres or 1.7198 hectares, more or less, of the land situated in or near the villages of Hazarpur and 3 others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of maintaining supplies and services essential to the life of the community for providing facilities for transport / communication, namely, for construction of Road from Panagarh on N.
