BIRBHUM—No. 813-L.A.(P.W.)/II-1/87.—7th March 1987—Whereas 2.6304 hectares (6.50 acres), more or less, of land situated in or near the villages of Paduma and Basahari, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3 (1A) of the Act for the public purpose of providing facilities for Irrigation and drainage, namely, for excavation of Minor from ch. 63-00 (left) of Distributary No. 5 Hinglow Main Canal;
