(II)/IR-72.—22nd December 1975.—Whereas the functions of the Central Government under the Land Acquisition Act, 1894 (Act 1 of 1894), in relation to the acquisition of land for the purposes of the Union have been entrusted to the State Government by notification No. 20/1/55-Judl, the 14th May 1955, issued by the Government of India, in the Ministry of Home Affairs, under Clause (1) of article 258 of the Constitution of India as S. R. O. 1074 and published at page 868, Part II, Section 3, of the "Gazette of India", dated the 21st May 1955;

And whereas the Governor is satisfied that land is needed for a public purpose, namely, for the construction of diversion of level crossing No. 34/C at Rajgram Railway Station in mile 161 to 163 in the village of Ambhua, jurisdiction list No. 14, police-station Murarai, district Birbhum, it is hereby declared that a piece of land as detailed below and measuring, more or !ess, •6293 of a hectare (1.555 acres) is needed for the aforesaid public purpose at the public expense within the aforesaid village of Ambhua.

This declaration is made under the provision of section 6 of the Land Acquisition Act, 1894 (Act I of 1894), read with the notification, to all whom it may concern.
