

Birbhum.—No. 15534L.A.(P.W.).—6th August 1959.—Whereas the Governor is satisfied that land is needed for a public purpose, not being a purpose of the Union, namely, for the construction of the Khayrasol-Panchra Road (section from Katari to Panchra), it is hereby declared that pieces of land altogether measuring, more or less, 8.75 acres and comprising cadastral plots as detailed below, are needed for the aforesaid public purpose at the public expense in the district of Birbhum.
