NOTIFICATIONS

BIRBHUM.—No. 7540-L.A.(II)/3M-3/70. — 17th June 1970.—Whereas it appears to the Governor that land is likely to be needed for a public purpose, namely, for construction of Dharmasala at Bakreswar in the village of Bakreswar, jurisdiction list No. 42, police-station Dubrajpur, district Birbhum, it is hereby notified that a piece of land as described in the schedule below and measuring, more or less, 0.1376 of a hectare (0.34 of an acre) is likely to be needed for the aforesaid public purpose at the public expense within the aforesaid village of Bakreswar;

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorise the officers for the time being engaged in the undertaking, with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

Any person interested in the above land, who has any objection to the acquisition thereof, may, within thirty days after the date on which public notice of the substance of this notification is given in the locality, file an objection in writing before the Collector, Birbhum.

BIRBHUM.—No. 7543-L.A.(I)/3M-3/70. — 17th June 1970.—Whereas it appears to the Governor that land is likely to be needed for a public purpose, namely, for construction of Dharmasala at Bakreswar in the village of Bakreswar, jurisdiction list No. 42, police-station Dubrajpur, district Birbhum, it is hereby notified that a piece of land as described in the schedule below and measuring, more or less, 0.6802 of a hectare (1.68 acres) is likely to be needed for the aforesaid public purpose at the public expense within the aforesaid village of Bakreswar;

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorise the officers for the time being engaged in the undertaking, with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

Whereas the Governor being satisfied that the land described in the aforesaid schedule is urgently needed for the aforesaid public purpose, he, in exercise of the powers conferred by sub-section (4) of section 17 of the Land Acquisition Act I of 1894, is pleased to direct that the provision of section 5A of the Act shall not apply to the said land which is entirely arable and to which, in the opinion of the Governor, the provisions of sub-section (1) of section 17 of the said Act are applicable.
