LAND AND LAND REFORMS DEPARTMENT Land Acquisition NOTICE

BIRBHUM No. 105-L.A.(II)/Spl/P.W. (Road)—
24th June, 1992—Whereas 1.4164 hectares, (3.50 acres), more or less, of land situated in or near, the villages of Langal Bhangra and other described below, have been requisitioned under sub-section (I) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (IA) for the purpose of providing facilities for transport/communication, namely for construction of the approach road of the box-type Bridge over River Brahmani connecting to Deucha—Baliarpur Road.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for the public purpose as aforesaid.

This notice is given under the provisions of Sub-section (Ia) of section 4 of the West Bengal Land (Requisition & Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.

A plan of the land may be inspected in the office of the collector, Birbhum. (Special Land Acquisition Department) Suri.
