BIRBHUM—No. 725-LA (II) (RR&R) Dated, the 13. 2. 91, File No. 5S-1/91.—Whereas 35 acre (1416 hectare), more or less, of land situated in near the Villages of Kirnahar & Gomai, described below, have been requisitioned under Sub-Section (1) of Section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under Section 3 (1A) of the said Act for the public purpose of creation of better living conditions in urban or rural areas by construction and reconstruction of dwelling places for people residing in such areas or for purposes connected therewith and incidental thereto, namely, for regularisation of Nabapalli-II Post '50 Squatters' Colony.
