

**Birbhum.**—No. 10338L.A.(F.W.).—28th June 1961.—Whereas 20.945 acres, more or less, of land situate in or near the villages of Mirpur and six others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the public purpose of providing facilities for irrigation and drainage, namely, for excavation of Distributary No. 7A of Mayurakshi Dwarka Branch Canal in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
