Birbhum.—No. 9018L.A.(P.W.).—14th May 1958.—Whereas 8.94 acres, more or less, of land situate in or near the villages of Chhota-Alunda and six others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for strengthening safety of the marginal bundh of Mayurakshi-Bakreswar Branch Canal from chainage 85.40 to chainage 94.00, chainage 188.50 to chainage 194.50, chainage 400.50 to chainage 406.00, chainage 444.00 to chainage 449.90, chainage 743.00 to chainage 798.85 and chainage 1114.00 to chainage 1116.00 in connection with Mayurakshi Reservoir Project;
