BIRBHUM.—No. 12678L.A.(P.W.)/II-156/79.—30th August 1979.—Whereas .9854 of a hectare (2.435 acres) more or less of land situated in or near the villages of Nachansha and two others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for constructing watercourse from chainage 60.00 of Minor No. 2 of Distributary No. I of Kopai South Main Canal ;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for the public purpose as aforesaid.

This notice is given under the provision of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
