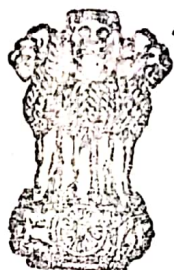

LAND AND LAND REFORMS DEPARTMENT Land Acquisition NOTIFICATION

BIRBHUM No. 11227-L.A./P.H.E./IW-48/97 dated 24th November, 1997—Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz. for sinking of deep tube-well under Bolpur W/s Sanitation and Health Education Project under Bi-lateral Assistance programme in the district of Birbhum.

Mouza Kankuliya, Jurisdiction List No. 106, P.S. Bolpur. It is hereby notified that for the above purpose a piece of land, comprising revisional settlement plot as detailed below and measuring, more or less 0111 hectare (0275 acre), bounded as specified below is likely to be needed within the aforesaid mouza Kankutiya.

This notification is made under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer Birbhum, Suri.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey the land and do all other acts required or permitted by that section.

Any person interested in the above land, who has any objection to the Acquisition thereof, may, within thirty days after the date on which public notice of the substance of this notification is given in the locality, file an objection in writing before the collector Birbhum Suri.
