## NOTIFICATION

BIRBHUM. — No. 14456L.A./1R-6/64. — 23rd August 1966.—Whereas the functions of the Central Government under the Land Acquisition Act, 1894 (I of 1894), in relation to the acquisition of land for the purpose of the Union within the State of West Bengal have been entrusted to the Government of West Bengal by notification No. 20/1/55 judl.(1), dated the 14th May 1955, issued by the Government of India in the Ministry of Home Affairs under clause (1) of Article 258 of the Constitution of India as S.R.O. 1074 and published at page 868, Part II, Section 3, of the "Gazette of India", dated 21st May 1955;

Now, therefore, in exercise of the powers conferred by section 48(1) of the Land Acquisition Act, I of 1894, the Governor is pleased to withdraw from the acquisition of a piece of land starting from mile 121 to mile 122, on the Sahibganj Loop (Loop line) comprising parts of cadastral survey plots 1343, 1348, 1349, 1351 and 1380 of mauza Harisara, jurisdiction list No. 1, police-station Sainthia and parts of cadastral survey plots 9, 15, 21, 25 and 9/2586 of mauza Parulia, jurisdiction list No. 70, police-station Mayureswar, pargana Dari Mayureswar, district Birbhum, and measuring, more or less, 2.19 acres, out of the total area of 2.53 acres declared for acquisition under declaration No. 3748L.A./1R-6/64, dated 3rd March 1964, published at page 606, Part I, of the "Calcutta Gazette, Extraordinary", of the 4th March 1964 for the purpose of construction of double line on the Sahibganj Loop (Loop line) between Sainthia and Burharwa from mile post 121 to mile post 123, in the villages of Harisara, jurisdiction list No. 1, police-station Sainthia, Purulia, jurisdiction list No. 70, Bajitpur, jurisdiction list No. 8, Pathai, jurisdiction list No. 10, Hossainganj, jurisdiction list No. 11, police-station Mayureswar, pargana Dari Mayureswar, district Birbhum.

—Whereas the functions of the Central Govern-

And whereas the Governor is satisfied that land
