#### NOTICE

BIRBHUM—No. 15 L. A. (II)/Spl./P.W (Rds.)—  
dt. 18th October, 1993—Whereas 2.93 acres or 1.1857  
hectares, more or less, of land situated in or near the  
villages of Faridpur & Kusumdihi described below have  
been requisitioned under sub-section (1) of section 3  
of the West Bengal Land (Requisition and Acquisition)  
Act, 1948, by the person authorised under the said  
section 3 (1A) for the purpose of providing facilities  
for transport/communication namely, for construction  
of New Agoya Bridge approaches on Ahmedpur-Kirna-  
har-Ramjibanpur Road (3rd K.M.P.).

Now, therefore, notice is hereby given that in  
pursuance of section 4 of the said Act, the Governor  
acquires such land being required for a public purpose  
as aforesaid.

This Notice is given under the provisions of sub-
