BIRBHUM—No. 121-L.A. (II)/Spl. / I. & W. dated—24th June, 1992—Whereas 3.14 acres or 1.2708 hectares, more or less, of land situated in or near the villages of Purba-Islampur and another described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for irrigation, namely for the Constructing Minor No. L/2, off-taking from Chainage 837.00 (R. B.) of Dy. No. 3A of Kopai South Main Canal.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This Notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, (West Bengal Act II of 1948), to all whom it may concern.

A plan of the land may be inspected in the office of the Collector, Birbhum (Special Land Acquisition Department), Suri, Birbhum.
