NOTICE

Birbhum. — No. 9650L.A.(P.W.). — 29th May 1956.—Whereas 29.19 acres, more or less, of land situated in or near the villages of Bandhgora and 3 others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for minor No. 1 of Distributary No. 2EX. Kopai South Main Canal in connection with Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
