NOTICE

BIRBHUM—No. 57 L A (II)/Spl/I & W dt. 23rd June, 1992— whereas 25 acre or 1012 hectare, more or less, of land situated in or near the villages of Salisanda and Sujapur described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for irrigation / drainage, namely, for Dy. No. BNM/6/2/4 from Ch. 12.00 Rt. Bank and from Ch. 0.00 to Ch. 4.10 Rt. Bank of Dy. No. BNM/6/2/4/1.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, West Bengal Act II of 1948, to all whom it may concern.
