

NOTICE

BIRBHUM.—No. 13213-L.A (P.W)/11-238/82.—18th November 1982.—Whereas 2.1468 hectarese 5.305 acres), more or less, of land situated in or near the villages of Badhgram and Brahmandihi described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3 (1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for Minor No.1 off taking from ch. 91.00 (L-B) of Dy. No.4 of Hinglow Main Canal;
