BIRBHUM No. 128-L.A./18/99-2000/B.H.W.D./2002 dated 12th June, 2002—Whereas it appears to the Governor that land is likely to be needed to be taken by the Government at the public expense for a public purpose, viz, for construction of Bolpur-Rajgram Road (from 16 KMP to 18 KMP) in the mouza(s) Kuchuighata, Ahammadpur & Paschim Sahapur, Jurisdiction List No(s) 148, 154 & 142, respectively P. S. Sainthia, District Birbhum it is hereby notified that for the above purpose a piece of land comprising revisional settlement Plots as detailed below and measuring, more or less, 3.6889 hectares (9.115 acres), bounded as specified below is likely to be needed within the aforesaid mouza(s) Kuchuighata,, Ahmmadpur & Paschim Sahapur.

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the office of the Special Land Acquisition Officer, Birbhum at Suri.

In exercise of the powers conferred by the aforesaid section, the Governor is pleased to authorise the Officers for the time being engaged in the undertaking,

Any person interested in the above land, who has any objection to the acquisition thereof, may, within thirty days after the date on which public notice of the substance of this notification is given in the locality, file an objection in writing before the Collector, Birbhum.
