BIRBHUM No. 26-L.A./2/2000-2001/A.D.B./2001 dated 26th March, 2001—Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz, for widening of Panagarh to Moregram Road in the mouza Barsal, Jurisdiction List No. 72. P. S. Rampurhat, District Birbhum, it is hereby notified that for the above purpose a piece of land comprising L. R. Settlement Plots as detailed below and measuring more or less, 1.3780 hectares (3.405 acres), bounded as specified below is likely to be needed within the aforesaid mouza Barsal.
