10th November 1969. — Whereas 8780 hectares or (2.17 acres), more or less, of land situate in or near the village of Khanra and others described in or near the village of under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person ~~authorised~~ authorised under section 3 (1A) of the Act for the public purpose of providing facilities for irrigation, namely, for excavation of Minor no. 1 of District No. 19 Ex-Kopai - South Main-Canal in connection with the Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for above purpose as aforesaid.
