NOTICE

BIRBHUM— No. 99-L A (II)/Spl/P W (Road)—24th June, 1992—Whereas 1·0326 hectares (2·55 acres), more or less, of land situated in or near the villages of Karimpur and other described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for transport/communication, namely for construction of Link Road to Jagadhari Math from Nalhati-Bautia Bhabanandapur road (533 M).

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948) to all whom it may concern.
