DECLARATION

Birbhum No.3176 LA(II)/1M-125/94/Power

Dated 20th June, 1995.

Whereas the Governor is satisfied that land is needed for a public purpose, not being a purpose of the Union, namely for Bakreswar Reservoir for Bk.T.P.P. in the mouzas Modapa and Bandhersole, Jurisdiction list Nos. 89 and 100, P.S.-Dubrajpur, District-Birbhum, it is hereby declared that a piece of land comprising Revisional Settlement plots as detailed below and measuring more or less, 31.7690 hectares (78.55 acres) bounded as specified below is needed for the abovesaid public purpose at the public expense within the aforesaid mouzas.

NOTIFICATION

Birbhum No. 9346-LA/4P-105/97/Power

Dated : 6.10.97

Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the Public expense for a public purpose viz, for construction of Bakreswer Reservoir in the Mouza Modapa, Jurisdiction List No. 89, P.S. Dubrajpur, District Birbhum, it is hereby notified that for the above purpose a piece of land comprising Land Reforms plots as detailed below and measuring, more or less 0.8984 hectare (2.22 acres), bounded as specified below is likely to be needed within the aforesaid Mouza Modapa.

This notification is made under the Provision of Section 4 of Act I of 1894, to all whom it may concern.

A plan of the land may be inspected in the Office of the Special Land Acquisition Officer, Birbhum, Suri.

In exercise of power conferred by the aforesaid Section, the Governor is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen, to enter upon and survey the land and do all other acts required or permitted by that section.

In exercise of the Powers conferred by sub-section (4) of Section 17 of the land Acquisition Act 1894 (Act I of 1894) the Governor is pleased to direct that the Provisions of Section 5A of the Act, shall not apply to the lands as described in the Schedule below to which in the opinion of the Governor, the Provisions of Sub-section (I) of Section 17 of the said Act are applicable.
