DESCRIPTION OF THE LAND

BIRBHUM No. 82-L.A./20/98-99/P.W.D.(R)/2000 dated 13th November, 2000,—Whereas the Governor is satisfied that land is needed for a public purpose, not being a purpose of the Union, namely for construction of Bolpur—Rajgram Road (Sec. from 20 K.M.P. to 21 K.M.P.) in the mouza Kagas, Jurisdiction List No. 135, P.S. Sainthia, District Birbhum, it is hereby declared that a piece of land comprising L. R. Settlement plots as detailed below and measuring, more or less, 3.1505 hectares (7.785 acres), bounded as specified below is needed for the above said public purpose at the public expense within the aforesaid mouza.
