BIRBHUM- No. 2790-L.A(R.W)/2R-38/76 - 12th February 1976 - Whereas 5.9134 hectares (14.619 acres) more or less, of land situated in or near the villages of Kanakpur and others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for transport and communication, namely, for the construction of Dubrajpur-Khayrasole to Barahra, Jamtara via Kasalia Halt State Highway;

Now, therefore notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.

A plan of the land may be inspected in the office of the Collector, Birbhum at Suri.
