

BIRBHUM.—No. 9495-L.A.(P.W.)/CII.—24th July 1968—Whereas .5640 hectare (1.405 acres), more or less, of land situate in or near the villages of Sakad² and Goaldihi described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) for the public purpose of providing facilities for irrigation and drainage, namely, for Sub-Minor No. 1R of Distributary No. 4 Ex. K.S.M.C. off-taking from chainage 95.00 (R.B. of Distributary No. 4 in connection with Mayurakshi Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provision of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
