

BIRBHUM.—No. 15002 LA(P.W)/II-100/77.—23rd November 1977.—Whereas 1·9101 hectares (4·72 acres) more or less, of land situated in or near the villages of Purba-Siur and others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for the construction of a new minor with water-course from tail end of Distributary 4/B.K.B.C. in connection with the Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
