

Birbhum.—No. 6911L.A.(P.W.).—26th April 1963.
—Whereas 30.875 acres, more or less, of land situated in or near the villages of Khala and two others, described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for Sub Minors of Minor No. 2, Distributary No. 4, K.S.M.C., in connection with Mayurakshi Reservoir Project;

Now therefore, notice is hereby given that in pursuance of section 4 of the said Act the Governor acquires such land, being required for the public purpose as aforesaid.
