

**BIRBHUM.**—No. 1608-L. A. (P. W.)/II-273/70.—12th February 1971.—Whereas 17851 hectares, (1.94 acres), more or less, of land situated in or near the villages of Ghaga and Kalisankarpur, described below have been requisitioned under sub section(1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) for the public purpose of providing facilities for irrigation, namely, for the construction of Minor with continuous water course from chainage 380/R of Dwarka Brahmani Main Canal in connection with the Mayurakshi Reservoir Project;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948), to all whom it may concern.
