

BIRBHUM.—No. 1068-L.A.(P.W.)/2R-106/77.—1st February 1978.—Whereas 3·0384 hectares (7·515 acres), more or less, of land, situated in or near the villa- of Amlakuri and others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1a) of the Act for the public purpose of providing facilities for transport and communication, namely, for the construction of Rajnagar-Khairasol Village Road (length 4th M.P. to 5th M.P.);
