BIRBHUM.—No. 6045 LA(PW)/II-148/83.—19th, August 1983.—Whereas 1.9444 hectares (4.805 acres) more or less, of land situated in or near the villages of Kaferpur, Mahesgram and Nimra described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 31A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for minor from tail of Kopai South Main Canal/12 with continuous water course off-taking from chainage 1.00 (L) of the minor;
