 Whereas 5220 of a hectare (12.25 acres), more or less,
 of land situate in or near the village of Katiha, des-
 cribed below, has been requisitioned under sub-
 section (1) of section 3 of the West Bengal Land (Requisition
 and Acquisition) Act, 1948, by the person authorised
 under section 3(1A) of the Act for the public purpose
 of providing facilities for irrigation, namely, for
 construction of small minor with continuous
 water course from chainage 40.50 (14) of D.N.M. 6/1
 in connection with Mayurakshi Reservoir Project.
