BIRBHUM—No. 159 L. A. (II) / Spl. / PW (Road) 24th June, 1992— Whereas 8°18 acres or (3°3128 hectares), more or less, of land situated in or near the villages of Aliat and others described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (1A) for the purpose of providing facilities for transport / communication, namely, for construction of Rajnagar-Khayrasole V. R. (section from 6th M. P. to 7 Mile 430 ch.)

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.
