BIRBHUM.—No. 9405-L.A.(II)/IG-60/90.—21st September 1990.—Whereas 61-48 acres of 25-4909 lectares, more or less, of land situated in near the village of Gayespur and Others, described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act. 1948, by the person authorised under section 3 (IA) of the Act for the public purpose of maintaining supplies and services essential to the life of the Community and for purposes connected therewith and incidental thereto, namely, for setting up of a composit unit for sericulture under the centrally spon sored Scheme;
