

NOTICE.

No. 4178L.A.(P.W.)—28th February 1956.—Whereas 108.38 acres, more or less, of land situated in or near the villages of Ballavpur and other described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the purpose of providing facilities for irrigation and drainage, namely, for submerged area and for earthwork for Kopai South Main Canal in connection with the Mayurakshi Reservoir Project;
