

Birbhum.—No. 7960 L.A. (P.W.).—15th 1952.—Whereas 23,896 acres, more or less, of situate in or near the villages of Chhoto-Al Bondihi and others described below, have been requisitioned by the Collector of Birbhum, for the purpose of providing proper facilities for irrigation, namely, for the construction of Minor No. 2 of Mayurakshi-Bakreswar Branch Canal and Cart Bridge in connection with the Mayurakshi Reservoir Project, under section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948 (West Bengal Act II of 1948);
