NOTICE

BIRBHUM.—No. 5009 LA(P.W.)/II-115/83.—18th July 1983.—Whereas 3.8587 hectares (9.535 acres), more or less, of land situated in or near the villages of Monai, Bhowanipur, Laliapur and Daikota described below have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation and drainage, namely, for modification and extension of the Minor 57 of M.D.M.C. from chainage 540.85 to chainage 605.75;

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.
