BIRBHUM No. 90-L.A./30/2001-2002/B.K.T.P P./2001 dated 11th December, 2001-Whereas it appears to the Governor that land is likely to be needed to be taken by Government at the public expense for a public purpose, viz, for construction of Bakreswar Reservoir of BKTPP in the mouze Bherapathari, Jurisdiction List No. 51, P. S. Dubrajpur, District Birbhum, it is hereby nutified that for the above purpose a piece of land comprising revisional Settlement Plots as detailed below and measuring more or less, 0.7285 bectares (1.80 acres), bounded as specified below is likely to be needed within the aforesaid mouza Bherapathari.

This notification is made, under the provisions of section 4 of Act I of 1894, to all whom it may concern.
