BIRBHUM.—No. 528 LA(P.W.)/II-392/78.—12th January 1979.—Whereas 9.8702 hectares (24.39 acres), more or less, of land situated in or near the village of Gaharakuri described below has been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3(1A) of the Act for the public purpose of providing facilities for irrigation, namely, for Reservoir area of Hinglow Dam;
