Birbhum.—No. 5914L.A.(P.W.).—29th April 1960.—Whereas 80.29 acres, more or less, of land situate in or near the villages of Nakpur and 8 others described below, have been requisitioned under sub-section (1) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3(1) for the public purpose of providing facilities for transport and communication, namely, for the construction of Mollarpur-Rampurhat-Nalhati-Moregram State Highway (Section Nalhati to Moregram from 5th mile to end);
