

NOTICE

BIRBHUM— No. 427-LA (PW) /19-148/90, dated 30. 1. 91—Whereas 6.1130 hectares (15.105 acres), more or less, of land situated in near the villages of Keshabpur & others described below have been requisitioned under sub-section (I) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under section 3 (1A) of the Act for the public purpose of providing facilities for irrigation & drainage, namely, for Extension and modification of existing Minor from ch. 57.00 of M.D.M.C. from ch. 605.75 to ch. 670.75.

Now therefore notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition & Acquisition) Act, 1948, to all whom it may concern.
