BIRBHUM No. 71 - L. A. (II)/Spl./ P. W. (Road)
Dated, 24th June, 1992— Whereas 8:395 acres or 3:3973 hectares, more or less, of the land situated in or near, the villages of Panchra and two others described below, have been requisitioned under sub-section (I) of section 3 of the West Bengal Land (Requisition and Acquisition) Act, 1948, by the person authorised under the said section 3 (IA) for the purpose of providing facilities for transport / communication, namely for the F. D. R. Works on Dubrajpur-Pandabeswar Road at 10 K. M. and 11 K. M. along new alignment connected to Box type Bridge along with proposed Hinglow Bridge and to meet the proposed Block top Road.

Now, therefore, notice is hereby given that in pursuance of section 4 of the said Act, the Governor acquires such land being required for a public purpose as aforesaid.

This notice is given under the provisions of sub-section (1a) of section 4 of the West Bengal Land (Requisition and Acquisition) Act, 1948, (West Bengal Act II of 1948), to all whom it may concern.
